5. **Approval to Use Future Bickford Ranch Air Quality Mitigation Funds towards the French Meadows Forest Biomass to Energy Project.** *Adopt Resolution #18-18, thereby committing up to \$300,000 in future Bickford Ranch Air Quality Mitigation Funds received to help fund the delivery of biomass material to an energy facility from the French Meadows Project, consistent with the Bickford Ranch Development Agreement; and thereby authorizing the Air Pollution Control Officer to negotiate, sign, and amend as needed, associated agreements and contracts.*
