  - A. **Industrial Hemp Update**

As part of the process to begin developing county policy and regulation, county staff are conducting outreach and seeking input from the public regarding what hemp is, its legal status, potential concerns, how it is differentiated from cannabis, and how industrial hemp might one day fit into Placer County's landscape.
