If you challenge the proposed project in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the County at, or prior to, the public hearing. Administrative remedies must be exhausted prior to action being initiated in a court of law.

Materials related to an item on this Agenda that are submitted to the Zoning Administrator Clerk after distribution of the agenda packet, are available for public inspection in the Planning Services Division located at 775 North Lake Boulevard in Tahoe City, during normal business hours.

The subject property, Assessor's Parcel Number 093-093-005-000, comprises approximately .30 acres, is currently zoned Residential and is located at 3355 Edgewater Drive in the Tahoe City area. <p>1:40 p.m. JB</p> <p>APPROVED</p>	<p>VARIANCE PLN19-00111 BEGIN CATEGORICAL EXEMPTION SUPERVISORIAL DISTRICT 5 SUPERVISOR GUSTAFSON</p> <p>Notice is hereby given that the Placer County Zoning Administrator will conduct a public hearing, on the date and time noted above, to consider a request from the property owners, Pierre and Lisa Begin, for the approval of a Variance to reduce the front setback from Sugar Pine Rd from 45 feet from centerline of travelled way to 37 feet from centerline of travelled way in order to construct a 168 square foot covered entry and a 16 square foot addition of living area within the setback. The subject property, Assessor's Parcel Number 084-080-001-000 comprises approximately .29 acres, is currently zoned Residential and is located at 305 Sugar Pine Road in the Homewood area. The Zoning Administrator will also consider a finding of Categorical Exemption in accordance with Section 18.36.070 of the Placer County Environmental Review Ordinance (Class 5A1 – Setback Variances not resulting in the creation of any new parcel).
