YOU MUST notify this office at once should this animal show any symptoms of sickness, abnormal behavior or dies during the quarantine period. Notify Animal Control and the Health Department immediately. You are also warned that the escape of this animal from your custody for any reason is a violation of this order.

Any person violating this quarantine order is guilty of a misdemeanor (Section 2606(b), California Administrative Code) punishable by a fine not to exceed Five Hundred Dollars (\$500.00) or imprisonment not to exceed six (6) months, or by both such fine and imprisonment.
